1. Website operator

The website www.essensaciones.com (the “Website”) is operated by ESSENSACIONES GmbH, a Swiss limited liability company, Ziegelbrückstrasse 107, 8866 Ziegelbrücke (Glarus), Switzerland; UID/CHE-247.196.101; Commercial Register No. CH-160.4.006.530-2; e-mail essensaciones@essensaciones.com; telephone +41 (0) 76 624 74 91.

2. Purpose and scope

This Legal Notice governs access to and use of the Website. Specific services, in particular the online shop, customer accounts and B2B area, may also be subject to specific terms, purchase terms, the Privacy Policy, Cookie Policy or other rules.

Essensaciones may update the presentation, configuration, content and functionality of the Website and this Legal Notice. The version published on the Website is the current version.

3. Access, accounts and B2B area

Access to public areas of the Website does not necessarily require registration. Certain functions, online purchases or access to professional content and price lists may require an account or authorisation.

Users must provide accurate and up-to-date information and keep their credentials confidential. B2B accounts and B2B documents are intended exclusively for the authorised business customer and must not be shared with third parties without Essensaciones' permission.

Minors may use services involving a contract or purchase only where legally valid and, where required, with the involvement of their legal representatives.

4. Intellectual property

Essensaciones owns or is licensed to use the rights required for the Website and its content, including text, photographs, illustrations, logos, trade marks, designs, interfaces, catalogues and other materials.

Unless expressly authorised or permitted by law, reproduction, modification, distribution, communication to the public, substantial extraction or reuse of content is prohibited. Access to the Website does not transfer intellectual property rights.

5. Third-party links and services

7. Rules of use

Unless expressly stated otherwise, merely displaying a product or price list does not guarantee availability and does not constitute acceptance of an order. The applicable order confirmation and purchase terms determine when a transaction is concluded.

9. Liability and availability

Essensaciones takes reasonable measures to keep the Website available, secure and up to date, but cannot guarantee uninterrupted availability or complete freedom from errors or technical failures.

To the extent permitted by applicable law, Essensaciones is not liable for damage arising from circumstances outside its reasonable control, misuse of the Website, third-party services or external information. Nothing in this Legal Notice limits liability that cannot lawfully be excluded.

10. Privacy and cookies

Processing of personal data is governed by Essensaciones' current Privacy Policy and applicable law, in particular the Swiss Federal Act on Data Protection (FADP) and, where applicable, the GDPR.

Cookies and similar technologies are governed by the current Cookie Policy. Both documents are available through the Website.

11. Suspension and changes

Essensaciones may temporarily suspend functions for maintenance, security, technical reasons, force majeure or operational needs. Content and services may also be changed or withdrawn, subject to users' and customers' existing contractual and statutory rights.

12. Applicable law and jurisdiction

This Legal Notice is governed by Swiss law, without prejudice to mandatory protections that may apply to consumers or other users because of their place of residence or because activities are directed to their territory.

Disputes relating to the Website shall be heard by the courts competent under applicable law. In B2B relationships, to the extent legally permitted, jurisdiction shall lie at the registered office of ESSENSACIONES GmbH in the Canton of Glarus, Switzerland.

13. General provisions

If any provision of this Legal Notice is held invalid or unenforceable, the remaining provisions shall continue in effect to the extent legally possible. Failure to exercise a right does not constitute a waiver.
